Heart of Yew C.I.C. GDPR Policy

1. Introduction

Heart of Yew C.I.C. is committed to protecting the privacy and security of personal data. This policy outlines how we collect, use, and protect personal information in compliance with the UK General Data Protection Regulation (GDPR).

7. Data Sharing

We will not share personal data with third parties without the explicit consent of individuals, except in the following circumstances:

- In the case of safeguarding issues or emergencies.

8. Data Retention

We retain personal data only for as long as necessary to fulfil the purposes outlined in this policy. After this period, personal data will be securely deleted or anonymised. For example:

- **Financial records:** Retained for 7 years in compliance with legal requirements.
- **Health information:** Deleted after the event or activity concludes unless longer retention is legally required.

9. Data Security

We are committed to ensuring that personal data is secure. We have implemented appropriate technical and organizational measures, including:

- Secure digital storage and encryption.
- Restricted access to personal data to authorized personnel only.
- Regular reviews of data security practices.
- Paper records stored in secure locations.

10. Individual Rights

Under GDPR, individuals have the following rights concerning their personal data:

- **Right to access:** Individuals can request a copy of the personal data we hold about them.
- **Right to rectification:** Individuals can request corrections to inaccurate or incomplete data.
- **Right to erasure:** Individuals can request deletion of their personal data in certain circumstances.
- **Right to restrict processing:** Individuals can request that we limit the processing of their personal data.
- **Right to object:** Individuals can object to the processing of their personal data for certain purposes (e.g., marketing).
- **Right to data portability:** Individuals can request that their personal data be transferred to another organization.
